

The tender / quotation shall be submitted in a sealed envelope addressing to The Secretary, HWF CGHS Ltd. by 6pm of August 12, 2025.

Terms:

1. Bid(s) submitted by an Ineligible Bidder will be invalid and will not be considered by the society.
2. Society Management has the right at any time to terminate, extend the period or amend any particulars of the tender, whether or not a Bid has been received. Society Management will not be responsible to any Bidder for any costs, losses or damages incurred in relation to Bid.
3. Society Management has the right to or not to publish all Bids received, including any information submitted as part of the Bid, on the society website/project site.
4. Society Management does not warrant the accuracy of the information and other details in any Bid, and expressly disclaims liability for errors or omissions therein. Bidders are advised to make independent queries to verify the correctness or accuracy of all information and other details.
5. EMD of INR 5,000/- to be deposited along with the sealed envelope of bid.

6. EMD will be returned to unsuccessful bidder within 10 working days after the close of bidding.
 7. Without affecting any other rights of HWF CGHS Ltd, the EMD Amount will be FORFEITED if the Bidder:
 - withdraws its Bid after submission,
 - fails to accept Offer (if issued),
 - fails to provide any documents requested by society management,
 - is an Ineligible Bidder,
 - submits a fraudulent Bid or a Bid in bad faith; or
 - provides false or misleading information.
 8. A Bidder who receives the Offer is responsible for obtaining all requisite licences from the Authorities and comply with all the applicable statutory compliance requirements.
 9. Bidder will be responsible for the labour and their safety while working.
 10. The bidder shall be solely liable for all liabilities, claims, damage, including any claims from any third party, including statutory authorities, etc. that may arise or accrue on the Contractor or otherwise, in relation to the Works undertaken in terms of the tender after the Effective Date. Further, the bidder shall at all times, keep the Contractor, including all its affiliates / associates, and their respective directors, shareholders, officers, employees, representatives and agents, indemnified in this regard.
 11. The Bidder agrees to indemnify, hold harmless and defend the Society, its directors, authorized representatives or employees (together as "Indemnified Person") from and against all direct and indirect claims, losses, liabilities, obligations, damages, expenses and costs (including without limitation to legal fees) brought against any of its officers, directors, authorized representatives, employees or agents, resulting from, arising out of or relating to:
 - a) breach or non-performance of any of the bidder's representations, warranties, covenants, assurances, obligations, etc.
 - b) failure of the bidder to perform any of its obligations contained herein.
 - c) breach of any law, rule, regulation, notification or other statutory or legal provisions or requirements by the bidder.
 - d) any wilful misconduct or negligent acts by it or any of the bidder's officers, directors, employees or agents and any consequent accidents resulting therefrom.
- 1.1 The bidder shall also indemnify, defend and hold harmless the Indemnified Persons from any cost, liability or damage arising out of injury or destruction to the equipment and/or human life due to the acts or deeds of the bidder or their workers or their representative. All incidental expenses and compensation shall be borne by the bidder.
- 1.2 The Delhi-RCS or Courts at New Delhi, India shall have jurisdiction over all matters arising out of or relating to this Tender.
